

Any office bearer is liable to be removed from the office if such an officer bearer is found to be in opinion of trustees, an inefficient, indulging in malpractice or any other activities, which goes against the interest of trust.

9. MEETINGS OF THE GENERAL BODY:

1. The General Body shall ordinarily meet once in three months to scrutinize and adopt financial statements and accounts reports of the activities of the trust to draw up the budget and program of work from time to time and consider all other matters pertaining to the trust.
2. The Special meetings of the General body, giving five days notice with the agenda may be called by the president on his own accord.
3. The president shall convene a special meeting of the General body on the written requisition signed by not less than two members specifying the agenda to be discussed at the meeting.
4. The quorum for all the meetings for General body shall be three.
- No quorum shall be necessary for an adjourned meeting to consider the same agenda.
5. Notice of every meeting of the General body with the agenda shall be sent to the members by the Secretary in consultation with the President at least 5 days before the date fixed for the meeting.

10. OPTIONAL CLAUSE:

The president or in his absence any of the members of the trust chosen by meeting shall preside at all meetings of the General body and the president or the Secretary shall have a second or casting vote in case of an equal division of the members voting on any question before meeting.

11. FUNCTION OF OFFICE BEARERS:

1. The president shall be the custodian of all the documents such as securities and investments etc. of the trust and shall conduct and direct its business in accordance with these rules. The president shall also be the managing trustee of the properties of the trust.
2. The secretary shall in consultation with the president convene meeting of the General body, record the proceedings carry on all correspondence and do such other things as are entrusted to him by the president or the General body.
3. The trust shall receive all voluntary contributions and donations for the trust and other amounts placed at its disposal by the president. He shall keep regular accounts of income and expenditure and submit the same to the General body.

12. INVESTMENT/TRANSFER/BORROWINGS: ಹಿ.ಉ.ನೋ. ರಾಜಾಜಿವನ

1. The securities and investments funds of the trust shall be deposited in such schedule/Nationalized/Co-operative Banks as General body may select. Cheques drawn against the funds shall be signed by the president and the Secretary.
2. The funds of the trust not required for current expenses, may be invested in Govt. or in other public securities or to purchase of immovable properties or fresh mortgages on such properties and trust may sell mortgage or otherwise transfer the same as it may decide by a majority of 2/3rd of the members present at the General body meeting.
3. Documents and conveyances in respect of the transfer of the property belonging to the trust shall bear the signature of the president and secretary.
4. The trust may borrow money as against the security of trust property for the purpose of fulfilling its objects.
5. The President and Secretary either jointly or severally to operate all bank accounts opened in the name of the Trust and sign all cheques, dividends, Hundis etc.

14. ADDITIONS AND ALTERATIONS:

Additions, alterations and amendments in respect of any of the provisions of this constitution of trust may be proposed by any member at the meeting of the General body provided that the notice of the same shall have been given to the members as per Rule IX (5), such additions, alterations or amendments shall be deemed to have been passed only if supported by votes not less than 2/3rd of the members present at such a meeting and again if accepted by a subsequent special meeting of the General body convened for the purpose of considering the proposed changes and held at least a fort night after the date of the first meeting but not otherwise.

15. BYE-LAWS:

The General body shall have power to frame subsidiary rules not in-consistent with the constitution of the trust and its aims and objects.
