



Additions, alterations and amendments in respect of any of the provisions of this constitutions of trust may be proposed by any member at the meeting of the General body provided that the notice of the same shall have been given to the members as per Rule IX (5), such additions, alterations or amendments shall be deemed to have been passed only if supported by votes not less than 2/3rd of the members present at such a meeting and again if accepted by a subsequent special meeting of the General body convened for the purpose of considering the proposed changes and held at least a fort night after the date of the first meeting but not otherwise.

15. BYE-LAWS:

The General body shall have power to frame subsidiary rules not in-consistent with the constitution of the trust and its aims and objects.
