



No Amendments to the Trust Deed/ Memorandum of Association/Byelaws/Rules and Regulations shall be made which may prove to be repugnant to the provisions of section 2(15),11,12 & 13 & 80G of I.T.Act, 1961 as amended from time to time, FURTHER NO AMENDMENT SHALL BE CARRIED OUT WITHOUT THE PRIOR APPROVAL OF THE COMMISSIONER OF INCOME TAX.

The following new clauses 17,18,19,20,21 shall be added at page No.9, after existing clause 16

17. DISSOLUTION CLAUSE:

In the event of dissolution or winding up of the Trust/Society, the assets remaining as on date of dissolution shall under no circumstances be distributed among the trustees/members of the managing committee/ Government body but the same shall be transferred to another charitable trust/society whose objects are similar to those of this trust/society and which enjoys recognition u/s 80G of I.T.Act,1961 as amended from time to time.

18. IRREVOCABILITY CLAUSE:

The Trust formed shall be irrevocable




